Full Hook Up (Water, Electric & Sewer) - \$200

Electric Only - \$140

- Camping Spots are maintained year to year in the registered person's name from the year prior
 - Cass was A7 in 2021 she will be A7 in 2022
 - Once placed in a spot that is your spot
 - Movement is allowed when spots become available but only if approved by the Fair Board
 - YOU must register for the spot each year
 - YOU can let someone else camp in YOUR spot, but payment/registration needs to be in YOUR name
 - I.E. No registration in your name and a check in another's name... you will be contacted
 - Camping spots do not go with the camper if you sell your camper
 - If you let another person camp in your spot, they don't get the spot once you stop paying
 - Once YOU stop paying the Des Moines County Fair reserves the right to fill the spot with a person of our choice
 - A master map is maintained by the fair office – as openings do happen
- New Campers (you have no assigned spot) are placed on availability of openings – this will not be known till mid-June
 - We do get openings every year – Submit your registration form with payment early as we use the USPS postmarks to determine placement of NEW campers.
 - A New Camper list is not maintained year to year – So send that form in early each year
- We have a FULL HOOK UP WAITING LIST... maintained year to year
 - The list is based on the year you first submit a registration form with \$200 - This list dates to 2014
 - YOU ONLY STAY ON THE FULL HOOK UP LIST IF YOU SUBMIT A REGISTRATION WITH \$200 PAYMENT EVERY YEAR AFTER YOUR FIRST REQUEST.
 - I.E. In 2022 you submit a Registration with a check for \$200 and Add to Full Hook Up Circled – 2022 Becomes the first year requested BUT You MUST SUBMIT a registration in 2023 and each year thereafter with a check for \$200 for the fair to maintain your name on the Full Hook up list.
 - Simply Circling FULL Hook up with NO \$200 check doesn't get you added to the list
 - All Refunds will be issued AFTER Fair should you not get placed that year
 - Placement is based on availability of openings in full hook up area
 - There are no guarantees of placement
 - Refunds for non-placement will be issued AFTER Fair – there is always a chance to get in
 - If camping as a group, be sure to list your group members on the form
 - Requests of placement not by certain campers will be kept confidential

FORMS MUST BE MAILED FOR PROOF OF POSTMARK & ADDRESS - NOT HAND DELIVERED
POSTMARKS ARE USED TO DETERMINE PLACEMENT IN AVAILABLE SPOTS
