## **Des Moines County Fair Association Conduct Rules**

Section 174.3 grant the Des Moines County Fair Ass. "...sole and exclusive control over and management of...the fair" Conduct detriment to the wellbeing of the fair will not be tolerated and may result in the participant being prohibited from participating in or attending the Fair.

## **4H/FFA Conduct Rules**

All exhibitors and program participants are expected to be cooperative, courteous and a good 4H/FFA representative while on the Des Moines County Fairgrounds and/or participating in the Des Moines County Fair event and comply with Iowa Youth Code of Ethics which is part of this publication.

## **Standing to Protest**

Any interest individual may file a protest regarding a possible violation of the Code of Ethics or a general/department rule of the Des Moines County Fair. The protest shall be in writing. No protest will be considered based upon a complaint that a judge or judges are incompetent.

## **Protest Procedure**

When a protest is made as to the eligibility of the animal or article to compete in any class or to an interpretation of the rule or violation of the Iowa Youth Code of Ethics it must be made in writing and filed with DMC Fair Secretary Manager or the fair 4H Extension office before noon of the day following the one on which the class was shown or within 24 hours of when the possible violation occurred.

The DMC Fair Secretary Manager, DMC Extension Regional Director and FFA Advisor will immediately confer to determine the appropriate committee to consider the protest; included but not limited to department committee or school board directly overseeing FFA chapter identified in the protest.

Any decisions regarding the protest shall be made with a quorum of committee members present and shall be in writing. The quorum shall consist of majority of the members of the committee.

No committee member shall be entitled to vote on a matter involving his/her family or a matter in which he or she has a conflict of interest.

Any individual affected by the decision of a committee shall have a right to appeal pursuant to the protest procedures set out in paragraph 2.

## **Appeal Procedure**

When an appeal is made from the decision of a Committee, it shall be made in writing and filed with the DMC Secretary Manager within six (6) hours of receipt of the original decision of the committee.

Upon receipt of a written appeal, the Fair Board President and the Fair Secretary Manager will decide if it is an issue of "Eligibility to Exhibit", or "Other". "Eligibility to Exhibit" appeals will be turned over to the Elected Extension Council; all other appeals will be heard by the Fair board.

### **IOWA YOUTH CODE OF ETHICS**

Youth are expected to be sincere, honest and act in sportsman like ways always. Youth represent the entire program and their behavior reflects on their parents, leaders, club, and the entire youth program. All adults involved with the youth program, leaders as well as parents, are expected to set positive examples and serve as positive role models by what they say and do. Any youth who breaks the code of ethics or allows another person (adult or peer) to talk them into violating the code of ethics agrees to forfeit all prizes, awards, and premiums. The youth may also be prohibited from exhibiting at this and future exhibitions including the Iowa State Fair and other county, state, or regional exhibitions.

Youth agree to follow these guidelines:

I will do my own work, appropriate for my age and physical and mental development. This includes research and writing of exhibit explanations, preparing exhibits (such as sewing, cooking, refinishing, etc.), care and grooming of animals, etc. Adult assistance should help guide and support me, not do it for me.

All exhibits will be a true representation of my work. Any attempt to take credit for other's work, alter the conformation of animals, or alter their performance is prohibited. Copyright violation or allowing others to complete my exhibit is considered misrepresentation and is prohibited.

I will treat all people and animals with respect. I will provide appropriate care for animals.

I will present exhibits that are safe for consumption. All food exhibits will be safe to exhibit and for judges to evaluate. Other exhibits will be safe for judges to evaluate and for exhibition.

All food animals that may be harvested immediately following the show shall be safe for consumers and shall have met all withdrawal times for all medications and be free of volatile drug residue.

If any animal requires medical treatment while at the fair or exhibition, only a licensed veterinarian may administer the treatment. All medications that are administered shall be done according to the label instructions of the medication used.

My animal's appearance or performance shall not be altered by any means, including medications, external applications, and surgical procedures. Any animal that is found to have changed its appearance or its performance shall be disqualified from the show, and have penalties assessed against the exhibitor, parent and/or guardian by the management of the fair or exhibition.

I will follow all ownership and possession rules and, if requested, will provide the necessary documentation.

I will follow all livestock health requirements for this fair or exhibition, according to the state health requirements as printed in the premium book of the fair or exhibition. I will provide animal health certificates from a licensed veterinarian upon request from the management of the fair or exhibition.

By my entering an animal in this fair or exhibition, I am giving consent to the management of the fair or exhibition to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. If the laboratory report on the analysis of any sample indicates a presence of forbidden drugs, this shall be evidence that such substance has been administered to the animal either internally or externally. It is presumed that the sample tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the exhibitor, parent and/or guardian to prove otherwise.

I am responsible for my exhibit, and I will not allow others to violate this code on my behalf. By my entering an exhibit in this fair or exhibition I will accept any disciplinary action taken by the management of this fair or exhibition for any violation of this code of ethics and any other rules of competition of the fair or exhibition without recourse against the fair or exhibition.

I want my exhibit to be an example of how to accept what life has to offer, both good and not so good, and how to live with and learn from the outcome.

I will not be involved in any illegal activities while participating in 4-H and FFA events, including but not limited to alcohol, tobacco, or drug use.

I agree to conduct myself in an honest, ethical, and upstanding manner and I understand that disciplinary actions will result if these rules are violated. I understand that I am expected to represent the program in a positive manner. I have read, understand, and agree to follow this code of ethics, and any other rules of competition of the fair or exhibition as printed in its premium book.

### **GENERAL RULES - 4-H / FFA YOUTH DEPARTMENT**

These rules apply to **ALL** 4-H/FFA exhibitors/shows - in addition to any departmental rules. All entry dealing with the County Fair (enrollment, animal identification, fair entry, or records due) must be completed in 4-H Online 2.0 or the FairEntry program on or before July 1<sup>st</sup>

**ALL static, gardening/horticulture, clothing, communications, & livestock must be entered in FairEntry by July 1st!**

**There will be a \$50.00/per youth exhibitor fee imposed through July 15.**

If a member has not complied, by July 15<sup>th</sup>, the member will not be allowed to exhibit at the Des Moines County Fair for that year.

Any youth who is a member of any 4-H or FFA organization in Des Moines County is eligible to exhibit in classes in the Des Moines County Fair Youth Department. All members must have been enrolled by May 15, 2023.

Exhibitors must have been in 4th through 12th grades and not have graduated from high school before 2023. To exhibit at the Iowa State Fair, exhibitors must have completed 5th grade.

All exhibitors are expected to comply with state and county 4-H and FFA regulations in exhibit requirements.

Each committee has been empowered by the Fair Board and the Extension Council to run their own departments.

Exhibits not in compliance with rules (general, departmental, or class) will be contacted by the committee chair. **It is the responsibility of the exhibitor to read and understand all rules.** Committee chairs may issue warnings or disqualifications as the situation may warrant.

All exhibits are to be presented by the 4-H/FFA member. Anyone unable to bring and show their exhibit can ask the Extension Office for permission to have someone exhibit for them. 4-H/FFA members having more than one animal in a class may have another 4-H/FFA member show one of their animals. **Only a Des Moines County 4-H/FFA member can show.**

**Exhibits must be the work of the exhibitor during the current club year.**

All premium checks will be mailed to the exhibitor after September 1 and must be cashed within 90 days of issuance. **If they are not cashed within 90 days, they will become null and void and will not be reissued.** All premium money will be forfeited.

The Des Moines County Extension Office and the Des Moines County Fair Board assume no responsibility for loss or damage to any fair exhibit or other possession.

No overnight sleeping in the livestock areas from 9:00 P.M. to 6:00 A.M.

**ALL LIVESTOCK HOUSED AT THE FAIR ARE TO BY ON THE FAIRGROUNDS BY  
8:00 PM, TUESDAY, JULY 25**

**All 4-H/FFA livestock trailers must park in the northeast corner of the north parking lot.  
SCC requests that a block be placed under the jack stand or dolly when you unhooked.**

**SHEEP: Arrival at Fair- 10:30AM to 12:30PM, Tuesday, July 25**

**All Sheep (1<sup>st</sup>-12<sup>th</sup> Grade Bucket Bottle as well) must have a veterinarian inspection  
BEFORE BEING UNLOADED.**

**All Sheep must be weighed BEFORE BEING PENNED.**

**Weigh-In - 10:30AM - 12:30 PM, Tuesday, July 25**

**GOATS: Arrival at Fair – 10:30AM – 12:30PM, Tuesday, July 25**

**All Goats (1<sup>st</sup>-12<sup>th</sup> Grade Bucket Bottle as well) must have a veterinarian inspection  
BEFORE BEING UNLOADED.**

**All Goats must be weighed, 10:30AM – 12:30PM, BEFORE BEING PENNED.**

**SWINE: Arrival at Fair – 8:00AM – 10:00AM, Tuesday, July 25**

**Must have a veterinarian inspection BEFORE BEING UNLOADED.**

**\*NO SWINE TACK PLACED DURING CHECK-IN\***

**Weigh - In – 12:00PM, Tuesday, July 25**

**MARKET BEEF: Arrival at Fair - 7:00 AM - 8:00 PM, Tuesday, July 25**

**All cattle unload on the south side of the cattle barn.**

**1<sup>st</sup>- 12<sup>th</sup> Grade Bucket Bottle Calves must have a veterinarian inspection**

**Weigh-In - 5:00 PM - 8:00 PM, Tuesday, July 25**

**DAIRY CATTLE: All dairy cattle must be stalled by 8:00 PM on Tuesday, July 25**

**Except for milking cows. They may come in the day of the show  
and be excused after they are exhibited.**

**POULTRY: All poultry must be tested and inspected by a veterinarian BEFORE BEING  
PENNED. Testing is from 5:00 PM-7:30 PM, Tuesday, July 25.**

**After testing, poultry must be penned by 8:00 PM, Tuesday, July 25.**

**RABBITS: Arrival at Fair - 5:00 PM – 8:00 PM, Tuesday, July 25. All rabbits must be  
inspected by a veterinarian before being penned**

### **STATIC EXHIBITS GENERAL RULES**

Committee Members Chair: Dwight Byerly, Becky Purchase, Jennifer Lane, Nola DeBerg,  
and Bailey Minster

Premiums: Blue \$6.00, Red \$5.00, White \$4.00

Exhibits can be prepared by an individual 4-H'er, team of 4-H'ers or may be the result of a group effort. All 4-H'ers, individual or group, must meet the grade requirements to be eligible for county and state fair exhibiting.

A school project can be entered as an exhibit if a 4-H'er has set a goal(s) that can be accomplished by both a classroom assignment and an outgrowth of a 4-H project goal. **The intent is that a predetermined goal has been set.** The 4-H'er must realize that evaluation criteria and exhibit guidelines for each opportunity will be different and should prepare accordingly.

Some exhibits could fit in more than one class. The exhibitor should determine which class best relates to their goal. Members enrolled in a project they have carried previously are encouraged to study some new phase of that project if it interests them. Exhibits might be, but are not limited to, an actual project, poster, display box, report, notebook, model, video tape, audio cassette, etc.

**\*ALL static exhibits must be entered in FairEntry by July 1st! \*  
There will be a \$50.00/per youth exhibitor fee imposed through July 15.**

**Entry tags will be made available once exhibits are checked in on Monday, July 24.  
Exhibitor's name and class number should be securely attached to each piece of the exhibit including goal statements.**

**Exhibitors must wear a 4-H /FFA shirt while participating in the evaluation process (completely intact and not defaced). No hats allowed. Exception to this rule is noted in Fashion Revue, Clothing Selection, \$15 Challenge, and Communications.**

Evaluating will be done conference style. **If a 4-H/FFA member has a conflict with the time, he or she must contact the Extension Office to let them know of the conflict.**

**Exhibits must be claimed between 2:00 PM and 4:00 PM on Monday, July 31.**

Premium money will not be paid to an exhibitor if exhibits are removed before 2:00 PM Monday, Aug. 1.

Please do not consume any part of projects until State Fair delegates have been determined.

Due to security, 4-H'ers are discouraged from exhibiting items that have special meaning or historical value as the exhibit or part of an exhibit.

The 4-H member's goal and applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, quality of work and techniques and general appearance and design. The member's age and experience will be taken into consideration during evaluation.

**GOAL STATEMENTS - A written explanation, an audio recording, or video recording MUST accompany each exhibit. In that explanation, the exhibitor will respond briefly to the following questions about the exhibit:**

- a. What did you plan to learn or do? (What was your exhibit goal (s)?)
- b. What steps did you take to learn or do this?
- c. What were the most important things you learned?
- d. Optional: What ideas or plans do you have for the future based on what you have learned or discovered?
- f. Please label each page and piece.
- e. **Exceptions:** see specific goal requirements for Photography, Visual Art, Communications, Posters and Gardening.

Exhibits that do not comply with the class description, size guidelines, copyright restrictions, safety, and approved methods will be disqualified and not put on public display.

Exhibits with a goal that better fits a different department/class will be moved to that department/class, at the discretion of the chair of the department.

All judges' decisions are final.

If the exhibitor chooses a display to illustrate what was learned, the following maximum size guidelines apply:

Posters and banners are not to exceed 24"x 36". Chart or graph boards and model displays, etc. are not to exceed 48"x 48" in size - total for exhibit.

Display boxes are not to exceed 28" x 22" in height or width and 12" in depth.

Maximum size of chart boards, graph boards, project presentation boards is determined by measuring the **flat** (unfolded) dimensions.

**Exceptions:** see rules regarding display dimensions for Department 7 projects and Poster Communications.

Endangered and threatened plants and animals (including insects) or songbird feathers and nests should **NOT** be used in any exhibit. Game animals legally taken are acceptable. Live specimens of noxious weeds or invasive species are **NOT** permitted in any exhibit. Dried specimens are acceptable to use in exhibits.

Copyrighted materials or designs may not be used in an exhibit that is presented as original work by the exhibitor. Exhibitors must give include permission from the copyright holder/owner when using copyrighted materials. Exhibitors must give proper credit to the original source of all materials/designs used in exhibits. A copyright design cannot be displayed in a public setting (fair) without permission being granted from the owner of the copyright. When permission has been granted by the owner of the copyright, the exhibit will be displayed and labeled appropriately. **Those without permission cannot be displayed. You are not allowed to deface or cover up the 4-H Clover. In addition, internet usage must be documented with the exact website address, not a search engine: example-Pinterest.com. -you MUST use the next source.**

**For projects that require technology: computers, etc., members need to make their own arrangements for judging purposes. Call the Des Moines County Extension Office for assistance or provide your own.**

**GROUP PROJECT-** Consists of participation in an entry by 2 or more 4-H members. One goal sheet will be required, and one premium will be paid per group project. Premiums for group projects are \$25.00 for large groups, up to two (2) group projects, and regular premiums after that. Each member of the group project will receive a ribbon. Group entry is made by calling the Des Moines County Extension Office at 319-671-7165.

**STATE FAIR** - All members involved in the State Fair are responsible for their own transportation. The Extension Service will coordinate the transportation of the State Fair exhibits from the Exhibit Hall. There will be an informational meeting at noon on Saturday, July 29 in Exhibit Hall for members with State Fair exhibits. Large, bulky or special needs exhibits will be the responsibility of the individual 4-Her for transportation to the Iowa State Fair. Each family should be represented at this important meeting because preparation of exhibits is discussed. State Fair information is on page 31.

### **Check in will look something like the following:**

Exhibitor arrives at the gymnasium.

Exhibitor will sit down at a computer & check in exactly what exhibits he/she has brought to fair.

Exhibitor will receive entry tags and move to the supply table to attach tags to their exhibits.

Exhibitor will receive judges' sheet once entry tags are attached.

Exhibitor will wait in the hallway until a judge is available to begin the judging process.

Once all photography exhibits are judged, the judge will then place the Sticker ribbons on the exhibits

Judges' sheets will be taken to the checkout table and remain at the checkout table upon completion of judging. **DO NOT take your judges sheets with you!**

Photographs will be left at the checkout table and ribbons can be picked up at that time if the exhibitor wants the ribbon for their photography exhibit.

Exhibitors are responsible to attach ribbons and take exhibits to their club booth for display.

If your exhibit is selected for State Fair consideration, the goal statement **MUST** accompany the exhibit to the State Fair selection room.

### **DEPARTMENT 1 - ANIMALS**

#### **Class 10110 Animal Science**

An exhibit (other than the animal itself) that shows the learning about a large or small animal including beef, dairy cattle, dairy goats, dogs, horse & pony, meat goats, pets, poultry, rabbits, sheep, and swine. Ownership of any animal is not required.

#### **Class 10120 Veterinary Science**

An exhibit that shows learning about keeping animals healthy, animal diseases, animal/human health interaction, or other learning related to Veterinary Science.

### **DEPARTMENT 2 AGRICULTURE AND NATURAL RESOURCES**

#### **Class 10210 Crop Production and Plant Science**

An exhibit that shows learning about the growth, use, and value of field crops, plant growth, soils and soil fertility, or any other learning related to Crop Production and Plant Science.

#### **Class 10220 Conservation, Environment and Sustainability**

An exhibit that shows the connections between humans and their environment including energy, energy conservation, stewardship, creating habitat, etc.

#### **Class 10222 Entomology**

Any exhibit (excluding live specimens) that shows learning or is an outgrowth or an entomology or bee project experience. Includes specimen collections and may include products (ex: honey) or equipment as part of the display.

#### **Class 10224 Fish and Wildlife**

Any exhibit that shows learning about a fish and/or wildlife project or program such as identification, habitats, harvest, taxidermy, etc. Any specimens must have been legally taken and must include information about date and location of harvest, and who the specimen was acquired from if not self-harvested. Feral pigs (including Russian/European Boar) are NOT permitted in taxidermy exhibits.

#### **Class 10226 Forestry**

Any exhibit, including collections, that show learning from participation in a forestry project or program.

#### **Class 10230 Horticulture and Plant Science**

##### **The Grace Mathews Memorial Rosette to the Best Horticulture project.**

An exhibit that shows learning about the growth, use, and value of plants, soils, small fruit production, vegetable and flower gardens, plant nutrition, careers, etc. (Garden crops and herbs are exhibited in classes in the Gardening Department.)

## 2023 Des Moines County Fair

### **Class 10235 Home Grounds Improvement**

An exhibit that shows learning about landscape plans, selection of landscape plants, ornamental garden features, home yard improvement, storage sheds, careers, etc.

### **Class 10240 Outdoor Adventures**

An exhibit that shows learning about backpacking, biking, camping, canoeing, fishing, hiking or other outdoor activities.

### **Class 10250 Safety and Education in Shooting Sports**

An exhibit that shows learning about safe and responsible use of firearms and archery equipment or wildlife management. (The exhibit may not include actual firearms; archery equipment allowed if tips are removed from arrows).

### **Class 10260 Other Agriculture and Natural Resources**

An exhibit that shows learning about agriculture or natural resources and does not fit in any of the classes listed above.

## **DEPARTMENT 3—CREATIVE ARTS**

Multiple entries are allowed per class, but different techniques must be used. Exception to this is in Photography (see Class 10320 for entry total).

### **Class 10310 Music**

An exhibit that shows learning about musical performance, composition and arrangements, instruments, musical styles, or history.

### **Class 10320 Photography**

Exhibitors are allowed 6 TOTAL entries in classes 10320, 10340, and 10345.

Participants will receive a sticker ribbon, instead of a fabric ribbon, during judging with premiums remaining the same. Fabric ribbons can be obtained when the photographs are left at the checkout table if the participants want them.

An exhibit, either photo(s) or an educational display, that shows learning about photography from choosing a camera to modifying your photo. Still photos only, not video.

### **Photography Special Rules:**

Photographs may be either black and white or color.

They may be processed from negatives, slides or digital cameras and computer manipulation programs.

Photographs must have been taken since county fair of the previous year.

## 2023 Des Moines County Fair

Photographs should be a minimum of 5"x7". Finished size (including mounting/matting) of photographs should not exceed 11"x14". Exception: Panoramic photos must not exceed 24" in length.

All photographs must be printed on photographic paper and must be mounted and/or matted. Maximum thickness of finished project must not exceed 1/4" thick.

Mounted photos can be (a) flush mounted (no board showing) on mounting board, or (b) with mount borders [window mat or flat mount directly on board]. Exhibitors may cut their own mounting boards, use ready cut window mats or have matting done professionally.

4-Hers are responsible for design decisions such as border, color, and size.

**Framed photographs (including floating frames) will not be judged.**

A series is a group of photographs (3 to 5) that are related or tell a step-by-step story. Photographs must be mounted together in a story order or sequence. Finished size of individual photos should not exceed 6"x8".

Edited photos should include a copy of the photo before edits.

Subject matter of photographs must be in good taste and appropriate for public display in a 4-H setting.

Photographs depicting unsafe practices or illegal activities will not be displayed.

Iowa State Fair 4-H photography exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits.

Exhibitors entered in 4-H Photography are not eligible to exhibit in the FFA Photography Show and vice-versa.

### **Life in Des Moines County**

**Rosette will be awarded by the Stover Family.**

This photo award has been initiated for all 4-H members of Des Moines County to participate in.

**The award will feature photos taken in Des Moines County only.**

Photos may include landscapes, animals, buildings, or people in any of our four seasons of the year.

Rules for Class 10320 as above and special rules listed below apply.

- \* Must be no smaller than 5"x7"
- \* Entries may be vertical or horizontal
- \* The photos must be on high quality photo paper and while not required it is encouraged that they be matted.
- \* All entrants must have sufficient permission of any recognizable person appearing in the photograph to grant the Des Moines County Extension Service the right to display their photographic submission either online or in printed material.

#### **Class 10340 Creative Photography -**

A photographic image that was creatively edited or modified beyond reality in a creative, imaginative, and experimental way to make it more interesting and visually engaging. Could be a composite of multiple photographs.

#### **Creative Photography Special Rules:**

Photograph/Image may be mounted/matted or submitted (uploaded) as a digital image

If mounted, photograph/image must be mounted on foam core no smaller than 4" in length and no larger than 14" in length.

Photograph/Image can be digitally created or from film negative.

Photograph must be on photo paper, canvas, or other flat material.

Exhibit must have the most current Photo Exhibit Label on back with required information for photo exhibits. Exhibit write up should include additional information about the processes and decisions used to develop exhibit.

Subject matter must be in good taste and be appropriate for public display in a 4-H setting.

Photographs depicting unsafe practices or illegal activities will not be displayed.

**Class 10345 Photography Idea/Educational Display -** An exhibit that demonstrates learning about photography that does not fit into any previous photography class. This class may include educational displays about printing, processing, editing, marketing, branding, merchandising, etc.

**Class 10540 Digital Storytelling** – (Entries will be entered through Personal Development Class 10540) – An exhibit that demonstrated the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques, or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video.

**Class 10350 Visual Arts Original Art** - An exhibit that shows learning through creation of original art. An original art piece is a one of a kind, no replicable design of your creation. By using one medium or a combination, an individual creates an authentic work of art that is not recognizable as another's work. You must explain the application of the most relevant design element(s) and art principle(s) featured in this exhibit. Describe your inspirations, reasons, feelings, and/or motives for creating this work of art.

**Class 10355 Visual Arts - Design, Process, or Technique Exploration** - This class emphasizes process and provides the opportunity to explore a medium, practice a skill, or study and apply elements and principles of art and design. An explanation of the application of design elements or art principles used when making the exhibit must be included. This exhibit may be an object, portfolio, display, poster, or organized sketchbook. If a non-original design source is used, its origin (where the idea was found, any pictures, sketches, etc.) must be credited, acknowledged, or have copyright permission obtained. See Visual Arts Special Rule #5 and #6.

**Class 10360 Visual Arts - Visual Art Ideas/Topics** - Exhibits might include the study and research about an individual artist, style, craft, business, or marketing process, planning group tour, career options, etc.

### **Visual Arts Special Rules:**

Items entered for exhibition at the Des Moines County Fair/Iowa State Fair must be ready for display in the home, gallery, or intended final display location: pictures framed, wall hangings and pictures ready to hang, etc.

Make sure hangers are strong enough to support the item.

Command Strips or other quick attach products are usually not adequate hangers.

Items not ready for display will be dropped one ribbon placing.

Exhibits made from kits or preformed molds will not be accepted.

Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.

If the exhibit is a finished art object, the source of inspiration of the design, design sketches, or other process for creating the object and design must be included.

If the exhibit is a finished art object, information must be included explaining the application of design elements and art principles used in creation of the work.

Original works of art must be a creative expression of a design unique to the artist or represent a significant modification to an existing design to make a new and original statement by the artist.

Exhibition of derivative works created by a 4-Her is prohibited without the written permission of the original copyright holder/owner.

Use of copyrighted or trademarked designs, images, logos or materials in 4-H visual arts exhibits is prohibited unless written permission has been obtained from the copyright or trademark holder/owner.

### **DEPARTMENT 4 - FAMILY AND CONSUMER SCIENCES**

**Multiple entries are allowed per class, but different techniques must be used.**

#### **Class 10410 Child Development**

An exhibit that shows learning about children. Exhibits that include items intended for use with children (books, toys learning games, babysitting kits, etc.) should include information about what you have learned 1) about children while creating and using the exhibit and 2) what the child(ren) learned from use of the item(s) in the exhibit. Exhibit examples include careers in child development, caring for children with special needs, childcare, growth and development, safety and health, etc.

#### **Class 10420 Clothing and Fashion - Constructed/Sewn Garments & Accessories**

A constructed garment or accessory (sewn, knitted, crocheted, or other process) that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and clothing care. Exhibits must be intended to be worn by humans.

#### **Class 10422 Clothing and Fashion - Purchased Garments & Accessories**

Purchased garments or accessories that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and clothing care. Exhibits must be intended to be worn by humans.

#### **Class 10424 Clothing and Fashion - Other Ideas/Educational Exhibits**

Any other educational exhibit that shows learning about clothing and fashion including by not limited to design illustrations, exploration of clothing styles, careers, clothing care, etc.

## 2023 Des Moines County Fair

### **Clothing and Fashion Special Rule**

Outfits or accessories which will be worn during the Awardrobe Clothing Event may not be entered as a 4-H Iowa State Fair exhibit.

Exhibits in classes 10420 and 10422 must include information about application of design elements and art principles. Exhibits in class 10424 should include information about application of design elements and art principles if appropriate for the exhibit.

#### **Class 10430 Consumer Management**

An exhibit that shows learning through savvy budgeting, comparison shopping, money management, and consumer rights and responsibilities.

#### **Class 10440 Food & Nutrition - Prepared Product**

An exhibit of a prepared food product that shows skills or learning about cooking, baking, eating, and choosing healthy foods, safety practices through the making of a prepared food product.

#### **Class 10442 Food & Nutrition - Preserved Product**

An exhibit of a preserved food product that shows skills and learning about food preservation through the making of a prepared or preserved food product. Processed honey may be exhibited in this class.

#### **Class 10445 Food & Nutrition - Educational Display**

An educational exhibit (poster, report, display) that shows skills or learning about cooking, baking, eating, and choosing healthy foods, meal planning/preparation and service, safety practices, or food preservation. Exhibits showing learning about meal planning and service must include a menu.

See *Food & Nutrition Special Rules* below and HS 76 “Foods for Iowa 4-H Fairs - Quick Reference” guide for Classes 10440, 10442, and 10445.

**The Joanne Denney Memorial Rosette will be given to the Best Food & Nutrition project as selected by the judges.**

### **Food & Nutrition Special Rules**

Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged, or displayed.

All food products/exhibits should be appropriate for human consumption.

Food product exhibits must be prepared, baked, or cooked using only food grade utensils and containers.

Products that require refrigeration will not be accepted, judged, or displayed.

Meat jerky products are prohibited.

The recipe must be included for any prepared or preserved food exhibit, credit the source of the recipe. Preserved foods must include the Food Preservation Exhibit Label.

Only food processed after August 1, 2022, is acceptable.

Current USDA and /or Iowa State University guidelines for home food preservation must be used. Processed honey must include the Honey Exhibit Label.

Preserved food exhibits **must** include two product samples. One will be opened for evaluation and discarded; the second will be placed on display and returned to the exhibitor.

All perishable food products will be discarded when removed from display.

Prepared foods should be placed on firm disposable plate or flat cardboard. Place food product exhibit in a resealable plastic bag with entry tag fastened outside the bag.

Cookies, cupcakes, bars, muffins, rolls, etc. - four (4) to six (6) items

Cakes, loafs, pies, etc. - one (1) whole product

**\*\*\*Foods that are displayed in the club booth, must be one (1) cookie, cupcake, bar, muffin, roll, etc. or one (1) slice of cake, loaf, pie, etc.\*\*\***

The use of alcoholic beverages in the preparation or production of 4-H food exhibits is NOT permitted.

### **Class 10450 Health**

An exhibit that shows learning through food choices, physical activity, safe activities, skills such as first aid and CPR, careers, and healthy lifestyle choices.

### **Class 10460 Home Improvement**

An exhibit that shows learning in planning, improving, and caring for your home living space, including extended personal living areas immediately adjacent to the home. Exhibits may include new or refinished/reclaimed/restored items. Exhibits showing learning about home design, furniture, home accessories, and fabrics must include information about how design elements and art principles were applied.

### **Home Improvement Special Rule**

Items entered for exhibition at the Des Moines County Fair/Iowa State Fair must be ready for display in the home: pictures framed, wall hangings and pictures ready to hang, etc. Make sure hangers are strong enough to support the item.

Command Strips or other quick attach products are usually not adequate hangers.

Items not ready for display will be dropped one ribbon placing.

Exhibit write-up/information must include source of inspiration and/or references indicating where the idea or information was obtained, giving credit to original author(s)/designer(s)/artist(s).

### **Class 10470 Sewing and Needle Arts - Constructed Item**

An exhibit that shows learning and skill in sewing, knitting, crocheting, or other needle arts. May include the construction of household items such as pillowcases, curtains, table runners, quilts, wall hangings, or other items. Exhibits in this class are not intended to be worn by humans.

### **Class 10472 Sewing and Needle Arts – Other Ideas/Educational Exhibits**

Any other educational exhibit that shows learning about sewing and needle arts including construction techniques, use and care of fabrics and fibers, design illustrations, decorative processes, careers, etc.

**\*Note: Exhibits in classes 10470 and 10472 should include information about application of design elements and art principles if appropriate for the exhibit.**

### **Class 10480 Other Family and Consumer Science**

An exhibit that demonstrates learning about a family and consumer science topic that does not fit any previous Family & Consumer Science class listed.

## **Special Exhibition - THRIFTY MEAL CHALLENGE**

### **Class 10490 Thrifty Meal Challenge**

Create a balanced, nutritious meal for a family of four (4) that includes a serving from each of the five food groups with a budget of \$11.

#### **Thrifty Meal Challenge Special Rules:**

Each county may enter one (1) exhibit in this class

All entries will receive an evaluation and ribbon.

Exhibit may be from an individual or group effort.

The meal must serve four (4) people and the total expense on receipt(s) must not exceed \$11.

The meal must include a serving for each person from each of the five (5) food groups.

Recommended portion sizes per person: ½ cup fruit, ½ cup vegetable, 3 ounces protein, 1-2 ounces grain, 1 cup equivalent dairy.

The exhibit will be a poster (maximum size 20" x 30") that includes:

- a) Menu
- b) Meal type
- c) Copy of receipts (up to 2)
- d) Photos of participant experience
- e) Thrifty Meal Challenge Worksheet (required)

## DEPARTMENT 5 - PERSONAL DEVELOPMENT

**Multiple entries are allowed per class, but different techniques must be used. Exception to this is Poster Communications (see Class 10530 for entry total)**

### **Class 10510 Citizenship and Civic Engagement**

An exhibit that shows learning about or contributing to your community, your country, or your world.

### **Class 10520 Communication**

An exhibit that shows learning about written, oral, and visual communication skills. Includes learning from participation in Theatre Arts projects or programs such as puppets, stage design, etc. May include original creative writing, poetry, fiction, and non-fiction, etc.

### **Class 10530 4-H Poster Communication Exhibit**

Special poster exhibit to visually tell a story or idea about 4-H to the public. Exhibitors must use one of the following themes:

- \* 4-H is... (open to 4-H'er's interpretation)
- \* Join 4-H
- \* Opportunity4All (2022 National 4-H Week theme)
- \* Spy Your Potential (2023 Iowa 4-H Youth Conference theme)
- \* Best Days Ever (in 4-H) (Variation of Iowa State Fair theme)

### **Poster Communication Special Rules**

Only one poster per 4-H member may be entered.

All posters must be designed on, or affixed to, standard poster board or foam core board: size minimum of 14"x20" or maximum of 15"x22".

Posters may be vertical or horizontal. Posters may be any medium: watercolor, ink, crayon, acrylic, charcoal, oils, collage.

Posters **cannot** be 3-dimensional. Materials used to make the poster may **not** extend more than 1/8 inch above the poster or foam core board.

Each poster **must** have the completed Poster Exhibit Entry Form attached to the back.

Posters **cannot** use copyrighted material or exact copies of other promotional designs, such as the Iowa 4-H Youth Conference theme logo.

4-H members may include the 4-H clover in the poster.

All 4-H Communication Poster participants will be given Certificates of Recognition and written evaluation comments. Outstanding poster will receive Seals of Merit. Superior posters will receive Seals of Excellence.

### **Class 10540 Digital Storytelling**

(See also Creative Arts) An exhibit that demonstrates the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques, or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video.

### **Class 10550 Leadership**

An exhibit that shows learning about leadership skills and influencing others in a positive way.

### **Class 10560 Self-Determined**

An exhibit that shows learning as part of your 4-H adventure and does not fit any other class.

## **DEPARTMENT 6 SCIENCE, ENGINEERING & TECHNOLOGY**

**Multiple entries are allowed per class, but different techniques must be used.**

**Class 10610 Mechanics** - Any exhibit that shows skills or learning about general mechanics or engineering solutions or that involve a combination of skills.

**Class 10612 Automotive** - Repaired or restored vehicle. (Note: vehicles will be on display at the Iowa State Fair one day only, (tentatively Thursday, August 10).

**Class 10613 Automotive Educational Display** - An educational display showing learning about an automotive idea including automotive maintenance, auto operations, auto safety, or automotive system

**Class 10614 Electric** - Constructed or repaired article or educational display that shows skills or learning about electric wiring, appliances, lighting, electrical energy sources, safety, etc.

**Class 10615 Small Engine** - Repaired or restored operating engine or educational display or other type exhibit that shows skills or learning about small engines. This class includes repaired or restored lawn tractors, small motorcycles, go-karts, etc.

**Class 10616 Tractor** - Repaired or restored tractor. Note: A conference judging opportunity for exhibitors in Class 10616 will be offered during exhibit check-in. (Conference judging may not be available during all check-in times). Tractors will be displayed outside throughout the Iowa State Fair. Release time Sunday, August 20, after 7:00 p.m.

**Class 10617 – Tractor Educational Display** - An exhibit that shows learning related to tractors, tractor mechanics, tractor operations, or tractor safety.

**Class 10618 Welding** - Constructed item or educational display that shows skills or learning about welding.

**Class 10620 Woodworking - A Rosette will be given for Best Woodworking Project in Memory of Don Thie.** An exhibit that shows learning about wood, woodworking techniques, and safe uses of woodworking tools and machines. Exhibits may include newly constructed or refinished/reclaimed/restored wood items.

**Class 10630 Science, Engineering & Technology** - An exhibit that shows learning about or helps explain how science and technology help us interact with the world. Topics include biological and chemical sciences, computers & networking, earth & climate, geospatial mapping (GPS/GIS) or any other application of Science, Engineering, or Technology.

**Class 10632 Aerospace** - Educational display or other exhibit (including flyable models) showing learning about an aerospace idea or topic.

**Class 10634 Robotics** - Educational display or other exhibit (including working robots) that shows learning about robotics and robotic systems.

### **Science, Engineering, and Technology Special Rule**

Exhibitors entered in 4-H Science, Engineering, and Technology classes are not eligible to exhibit in similar FFA Ag Mechanics classes and vice-versa.

## **DEPARTMENT 8-GARDENING GENERAL RULES**

Members are limited to **TEN** exhibits in this department plus Market Garden Basket.

A member may exhibit up to **SIX** entries in any one of the following categories: vegetable, fruit, flowers, herbs, houseplants, or jumbo vegetables.

One combination of entries could be: six vegetables plus three other items that are fruit, flowers, herbs, houseplants, or jumbo vegetables.

**ONE entry per class. Entry tags and judges form MUST include genius name.**

All produce and flowers exhibited **must be from the member's own project**.

Produce exhibited must be fresh from the garden. Preserved products should be exhibited in Family & Consumer Science.

**Each exhibit should be labeled as to species and variety of fruit, vegetable, herb, flower, or house plant on a 3"x 5" card. Card will also include a record of the plant including planting date (for annuals), fertilizer (how much and when), care, and harvest date.**

Vegetable exhibits will be judged on the quality of the products as specified in Iowa State University publication 4-H 462 - "Harvesting and Preparing Vegetables for Exhibit." Flowers and houseplant exhibits will be judged on the quality of the products as specified in ISUEO publication 4-H 464 – "Preparing Cut Flowers and Houseplants for Exhibit." See publications for details.

Because judging is done on Monday, members may replace exhibits with fresh produce starting on Thursday, July 28.

**AFTER JUDGING, THE BUCKETS WILL BE DISPLAYED AROUND THE FAIR GROUNDS AND THE MEMBER WILL BE RESPONSIBLE FOR WATERING IT DURING THE FAIR. THE DISPLAY SHOULD INCLUDE A LIST OF SPECIES AND VARIETY OF EACH PLANT IN THE BUCKET.**

Des Moines County Master Gardeners will host an informational workshop in May for youth who are interested in entering this class. Attendees of this workshop will learn best practices for growing their bucket of flowers and will go home with supplies to start their project. ## **FASHION REVUE GUIDELINES**

The purpose of this class is to encourage the sewing of a personal garment or outfit.

Consideration is given to fit, color, style, suitability, attractiveness, quality of construction, stage presentation, and required care.

Youth participants will model, at the Des Moines County Fair, at least one garment or outfit, and **display second**, if applicable, that they constructed, hand-knitted, machine-knitted, or crocheted during the current 4-H year.

A garment or outfit consists of one to three pieces such as, but not limited to, party clothes, tailored suits, vest, slacks, shirt, skirt, active sportswear, and/or coats.

Blouses, shirts, and sweaters are usually considered as garments. If they are used to complete an outfit, they may be constructed or selected.

All other accessories and undergarments may be constructed or selected

Only juniors have the option of constructing one piece or all of the garments in the outfit. Intermediates and Seniors must construct the entire outfit.

### CLOTHING SELECTION GUIDELINES

The purpose of this class is to select and/or purchase an outfit that represents the 4-H'er's goal or intended use for the selected outfit.

Judging is based on fit, color, style, suitability, attractiveness, quality and construction features, stage presentation, required care, and cost comparison.

There is no consideration in the judging on the amount spent, only in the process of recordkeeping and reflection on the cost of the individual items as a part of the process.

Outfits may be purchased at a department store, boutique, online store, sidewalk sales, retail shops or mall stores.

Outfits may also be purchased at garage sales or other secondhand venues at any price point.

Outfits may be gifts, hand-me-downs, relative or friend's modern or vintage clothing, or existing personal clothing, if the 4-H member selected the item as part of this specific outfit for the stated purpose.

Home-sewn clothing that was not sewn specifically for the participant are acceptable, such as purchases from a used clothing store.

## **\$20.00 CHALLENGE GUIDELINES**

This class is designed to expand the 4-H member's shopping experience to shopping venues emphasizing recycling, reducing, and reusing.

Outfits must be purchased at a garage sale, consignment store, secondhand store, or similar place.

Online venues are allowed, must be second-hand in nature. Shipping and handling are not included in the total calculations.

Traditional shopping venues may not be used, regardless of a low regular or sale price.

Hand-me-downs or clothing as gifts do not qualify but may be entered in Clothing Selection if 4-H member selected the items to meet a specific purpose/goal.

Twenty dollars is the purchase price limit including tax. However, some secondhand stores and venues do not typically charge sales tax.

Receipt(s) for every item included as a part of the calculated total must be submitted with the entry. A garage sale receipt can be a piece of paper with the name of the location such as "Jane Doe garage sale", date, amount paid, and signature of person selling at the garage sale. If the outfit was free at a garage sale, "free" can be listed on the report form and on the receipt. Failure to provide receipts will result in a reduced evaluation.

An outfit consists of major clothing pieces such as a shirt and pants or a dress. Shoes, undergarments, and accessories are not included in the \$20 purchase price limit.

Alterations are permitted to achieve a desired look or fit.

There are no additional considerations for an outfit that cost less than \$20.

The outfit pieces should be purchased to meet the 4-H member's goal or intended use for the purchased outfit, and the 4-H member should have had an experience in choosing shopping alternatives, evaluating fit, quality and construction features, price, and cost comparison

**Entries in Educational Presentations, Working Exhibits, Extemporaneous Speaking and Share the Fun should be entered in FairEntry by July 1. Please let the Des Moines County Extension Office know of your intent 319-671-7165.**

## GENERAL INFORMATION

4-H members must use sanitary and safe procedures and methods at all times. Educational Presentations and Working Exhibits involving food must follow established food safety guidelines. This is tremendously important if samples are available to the viewing public. Appropriate storage of the food items and the sanitary handling of the food must be demonstrated by the 4-H'ers. Plastic gloves and hair nets are just a couple of items that should be considered and used as appropriate.

Working Exhibits and Educational Presentations may involve 1, 2 or more members. Team exhibits will receive one premium.

**4-H member must wear a 4-H shirt or emblem during presentations unless you are wearing a costume to enhance your performance.**

A Communication Recognition trophy will be awarded to selected 4-H members for continuous participation at the Des Moines County Fair with Communications projects. The awards will be presented by the Steffener Family.

Des Moines County can enter up to six Educational Presentations, four Working Exhibits, three Share the Fun acts and two Extemporaneous speakers at the 2023 Iowa State Fair.

Des Moines County will be scheduled to give Educational Presentations, Working Exhibits, and Share the Fun acts at the Iowa State Fair on August 10, 11, 15, and 18. The Extemporaneous Speaking Contest will be on August 14 (only for members who completed 12th grade in 2023), August 15, August 17, and August 20 (in the morning only). See State Fair section for details.

A 4-H member cannot represent the county in both Educational Presentation and Working Exhibits. If selected for State Fair, they must choose one or the other.

**Communication Exhibitors are expected to be present Wednesday evening, July 26, at 5:00 p.m. for Communication Night that will be held in conjunction with Share the Fun in Exhibit Hall.**

## WORKING EXHIBITS

Working exhibits provide an opportunity for 4-H members to communicate, interact with, and teach an audience in an informal and experiential way.

Members set up interactive demonstrations to provide instruction on how to make something or provide educational information.

Many stages of the exhibit or product should be ready so that any step can be discussed. No set format should be used. Questions that might be asked as starters are:

Have you seen. . . ?

Would you like to know how to. . . ?

May I show you how. . . ?

The best subjects involve action by the youth or involve the audience in some doing, feeling, tasting, smelling, or judging.

Participants should be prepared to give their Working Exhibit for about 30 minutes and have enough supplies for approximately 50 people.

All members with Working Exhibit entries are required to attend an orientation session at a venue to be determined as of the release of the fair book.

**During the times that the participants give their presentations, they will also be involved in a peer evaluations.**

The Des Moines County Cattlemen will present \$10.00 for any 4-H Working Exhibit using beef. Any color of ribbon is eligible. **You have actual beef or must be promoting beef in the exhibit and provide information about it.**

The Des Moines County Pork Producers will present \$10.00 for any 4-H Working Exhibit using pork. Any color of ribbon is eligible. **You must have actual pork or be promoting pork in the exhibit and provide information about it.**

**Qualifying Working Exhibits will receive a \$30.00 incentive sponsored by the Des Moines County 4-H Foundation.**

**A 4-H member may participate in only one working exhibit per year at the Iowa State Fair.**

### SHARE THE FUN

Share the Fun provides an opportunity for 4-H members to share their skills and talents before an audience purely for the sake of enjoyment. The presentation **must not exceed 6 minutes in length.**

Individuals, skits/acts must be sensitive to the diversity of the population. Individuals, skits/acts must be in good taste and not offensive to minority groups of citizens. Instrumental, vocal, speaking, etc., are acceptable forms of performances.

Any number may make up an act. Two or more clubs may be represented in an act.

All contestants will receive special "Share the Fun" ribbons. **\$25.00 premium will go to the large group (act/club) and \$13.00 to the small group (individual).**

To be eligible for the State Fair, members must have completed 5th grade. They must be an active member of an Extension sponsored youth group in the current year. If the act involves a club, or a group from a given club, at least 80 percent of the performing group must have completed 5<sup>th</sup> – 12<sup>th</sup> grade in 2023.

State Fair selected representatives are required to perform as part of the program at the Des Moines County Style Show on Saturday night, July 29.

**Qualifying Share the Fun performances will be awarded \$30.00 Visa gift card to help cover expenses as you travel to the Iowa State Fair sponsored by the Des Moines County 4-H Foundation.**

### EDUCATIONAL PRESENTATIONS

Educational Presentations provide an opportunity for 4-H members to demonstrate communication skills by presenting knowledge, information, or a process to an audience.

These presentations are like talks or demonstrations done on the club level. The educational presentation should be an outgrowth of the member's 4-H experience.

There are 2 classes in the Educational Presentation Program, a class for Juniors (grades 4-6) and Intermediate/Seniors (grade 7 & over).

A 4-H member may participate in only one educational presentation per year at the Iowa State Fair.

Educational Presentations may be given by one or more 4-H'ers.

The topic of presentation should determine its length but should not exceed 20 minutes.

Junior presentations should not exceed 15 minutes.

During the times that the participants give their presentations, they will also be involved in a peer evaluations.

The Des Moines County Pork Producers will present \$10.00 for any 4-H Educational Presentation using pork. Any color of ribbon is eligible. **You must have actual pork or be promoting pork in the presentation and provide information about pork.**

The Des Moines County Cattlemen will present \$10.00 for any 4-H Educational Presentation using beef. Any color of ribbon is eligible. **You must have actual beef or be promoting beef in the presentation and provide beef information.**

### EXTEMPORANEOUS SPEAKING

The Extemporaneous Speaking Contest is open to all 9th-12th grade 4-H members in Des Moines County.

This contest is designed to encourage the development of the communication skills by providing an opportunity to think, organize thoughts, prepare a speech, and to answer questions when given a limited amount of preparation time.

This event will begin with an orientation meeting following the Educational Presentations in the Little Theatre.

Each contestant will randomly select one of the available topics and all the topics will be related to 4-H.

Participants must be senior aged 4-H, having completed the 9th grade.

A maximum of two senior 4-H entries (grades 9th - 12th) per county are eligible to go to the State Fair.

During the times that the participants give their presentations, they will also be involved in a peer evaluations.

**A \$30.00 Visa gift card will be awarded to the qualifying senior participant(s) to help cover**

### **expenses as you travel to the Iowa State Fair sponsored by the Des Moines County 4-H Foundation.**

All participants are required to attend an orientation session.

Each contestant will draw three of the available topics, selecting one to speak on, thirty minutes before the contest.

The general nature of the topics will relate to 4-H.

The selected topic will not be available to the other contestants in the speakers' assigned room.

The other two topics will be returned to the available topics for other contestants.

A preparation room is to be used with one contestant per speaking site admitted initially and one additional contestant per speaking site admitted each ten minutes as the contest progresses.

A contestant may not leave the preparation room until it is time to speak, nor may a contestant receive help from a parent, leader, other adult, or any other youth.

Each contestant will have 30 minutes preparation time.

A contest official will assist contestants with the time requirements.

All reference material will be screened by a contest official on the following basis:

- a) Contestants may bring his/her own books, magazines, or newspaper clippings for reference during the thirty minutes of preparation.
- b) Reference material must be printed material such as books or magazines (cannot be notes, outlines, or speeches prepared by the contestant or by another person for the purpose of use in the program).
- c) Some relevant reference materials will be available in the preparation room. This material will consist of historical material related to the 4-H program.
- d) Each speech shall be the result of the 4-H'ers own effort using approved reference material which contestant may bring to the preparation room. No other assistance may be provided. Plain 3"x5" note cards provided must be used in delivering the speech.
- e) Only notes made during the preparation period may be used.
- f) Each speech shall be not less than four or more than six minutes, with five minutes additional time allowed for related questions which shall be asked by the judge. The contestant will be shown timecards in an ascending order (1,2,3,4,5) by the timekeeper. "Stop" will be used at six (6) minutes.

g) Each contestant will be introduced by a contest timekeeper by name and the contestant will be expected to introduce his/her speech by title only.

h) Contestants are not permitted to use any props, gadgets, posters, or audio-visuals of any sort. A podium will not be available.

Speeches will be evaluated using the following criteria:

- 1) Content related to topic;
- 2) Knowledge of the subject;
- 3) Organization of material;
- 4) Power expression;
- 5) Voice;
- 6) Stage presence;
- 7) General effect.
- 8) Response to questions.

A judge's critique/conference with each participant will be included as a part of the program.

**Members with exhibits selected for State Fair are expected to attend an informational meeting on Saturday, July 29, at 12:00 noon, in Exhibit Hall.** If they cannot attend, they should arrange for someone to represent them.

All members who have exhibits selected for the State Fair are expected to participate in the State Fair Exhibitors Parade 5:00 PM on Saturday night, July 29, in the Exhibit Hall.

### **GENERAL RULES FOR LIVESTOCK EXHIBITS**

All Livestock Exhibitors must have YQCA certification except dog, cat, and small pet.

All Market animals must be identified on the Livestock Identification form at weigh-in.

All breeding and commercial animals, dog, horse, bucket bottle calf, bottle lamb, bottle kid goat and dairy must be identified in 4-H Online 2.0 by **May 15**.

In addition, market animals must have their 4-H/FFA ear tags and swine must be ear notched. All forms of identification must remain in place until animal is removed from the fairgrounds.

Must have two members of a committee plus owner/representative present or a signed waiver form to weigh in livestock at the fairgrounds during the fair.

**Exhibitors are responsible for their livestock until sold or removed from the fairgrounds. Exhibitors will be asked to take their animals home if not given proper care.**

Chore time 7:00 A.M. - 9:00 A.M. and 4:00 P.M. - 6:00 P.M.

**ALL animals shown at the fair must be entered in FairEntry by July 1.**

The **General Rules** for the Youth Department (page 6) also apply to the Livestock Departments.

**\*\*ALL livestock must be entered in FairEntry by July 1st! \*\***  
**There will be a \$50.00/per youth exhibitor fee imposed through July 15.**

**All livestock stalled at the Fair (except pre-4-H) and horses must enter in FairEntry the stalling and bedding information and mail the appropriate fees by July 1 to the Des Moines County Extension Office, 1700 W Mt. Pleasant Street, West Burlington, IA 52655**

Each animal will be presented in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical, or other change for cosmetic purpose, save only branding, tattooing, foot trimming, dehorning, tail docking and shearing. The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other method per os (by esophagus) is prohibited and any animal testing positive for anabolic steroid or diuretic use shall be presumed to be altered and modified.

**No painting, dyeing, and /or use of color agents on animals including hooves, excluding horses' hooves.**

**It is the intent that the 4-H/FFA member take responsibility for caring for and grooming his/her own animals. If assistance is needed it should be aimed at helping the 4-H/FFA member learn new skills and be done by a family member and/or another Iowa 4-H/FFA member. Family members include and are limited to parents/legal guardian, brother, sister, or stepsiblings.**

Exhibitors must wear a shirt with a 4-H/ FFA emblem on it while participating in 4-H/FFA animal shows. Shirts must be completely intact and not defaced, long pants, closed shoes (no flip flops or sandals) and no hat will be allowed. Exception will be for Horse and Pony division (see page 40).

ALL ANIMAL EXHIBITS STAYING AT THE FAIR MUST BE IN PLACE BY 8:00 p.m. on Wednesday, July 25.

**Stall cards are required** for each stall, pen, entry of cattle, pen of other livestock or poultry and may be picked up at the 4-H Extension Office during the fair.

Livestock exhibitors must use wood chips for bedding

**Exhibitors are NOT allowed to bring large cooling devises, except for fans, to the fair. The Fair Board reserves the right to implement cooling devises when needed.**

All exhibits, except sale animals, may be removed after 2:00 p.m. on Monday, July 31. All exhibits and tack **must be removed** by 9:00 a.m. on Tuesday, August 1.

Livestock will be judged based on merit according to the requirements of the class entered. Judges of the respective divisions will determine if an animal is worthy of Champion or Reserve honors if there are fewer than two entries in breed, division, or class.

Champion and Reserve Champion Banners intended for display will be available from the Fair board and will then be the property of the exhibitor after fair.

All livestock premiums for the 4-H/FFA division will be \$10.00 paid the day of the show.

All exhibitors shall comply with the health requirements as listed.

### Health Requirements

**Any evidence of warts, ringworm, foot rot, pink eye, draining abscesses or any other contagious or infectious condition will eliminate the animal from the show and such animals will need to be removed from the fairgrounds.**

No individual Certificate of Veterinary Inspection will be required on animals or poultry exhibited at a county fair, 4-H and/or FFA Exhibition, except for those noted in a particular department.

Quarantined animals or animals from quarantined herds cannot be exhibited.

See individual departments for specific health requirements.

**THE DECISION OF THE OFFICIAL SHOW VETERINARIAN CONCERNING ANY ANIMAL HEALTH MATTER WILL BE FINAL.**

All injectable medications given to livestock at the Des Moines County Fair must be given by a licensed veterinarian.

Failure to follow this rule will result in loss of premium money or eligibility to exhibit.

### SHOWMANSHIP

**Members must own the animals which they enter in Showmanship Classes** (exception is horse).

Trophies will be awarded to the champion show person in each of the following divisions: Goat, Beef, Dog, Rabbits, Poultry, Dairy Cattle, Dairy Goat, Swine and Sheep and Horses.

Showmanship winners will be selected by the respective judges in the various divisions.

For showmanship classes, exhibitors must wear a 4-H or FFA shirt including a 4-H or FFA emblem.

**Once an exhibitor wins showmanship, that exhibitor is done competing for showmanship that day. He or she will compete in the next level the next year.**

Showmanship divisions are Junior (4-6 grades), Intermediate (7-9 grades) Senior (10-12 grades)

These are listed in the order the 4-H'ers will show.

Grade levels indicate the most recently completed grade in school.

## **HERDSMANSHIP**

**Conducted by each livestock committee**

Livestock exhibitors are expected to keep their quarters (includes stalls, tack areas, alleyways, etc.) orderly, neat, and as attractive as possible.

Herdsmanship duties are the responsibility of the exhibitor, **NOT** the parents, leaders, or other adults.

The entire livestock area will be inspected several times daily except for show time.

A couple of representatives from each club are encouraged to be around the livestock barns during the daylight hours.

### **HERDSMANSHIP EXPECTATIONS**

#### **I. CLEANLINESS OF ALLEYS AND STALL OR PENS**

Bedding adequate, bright, dry, clean and in place.

Animals securely tied or penned.

Feed boxes in front of animals only at feed time.

Manure hauled out and deposited in proper place.

Alleys swept clean, free of obstructions.

#### **II. ARRANGEMENT OF EXHIBIT**

Big objectionable boxes out of the way.

Hay and tack neat and orderly.

Feed boxes, blocking chutes and misc. gear in area provided.

#### **III. APPEARANCE OF ANIMALS**

Animals clean and brushed.

### **MARKET LIVESTOCK AUCTION SALE**

Market beef, hogs, sheep, and goats must have been exhibited in the various departments to be eligible for the auction.

Breeding stock is not eligible for the sale.

The sale clerk's record will be the official record for weights and prices.

Purchasers must clear each animal and make settlement with the animal's owner within a timely manner.

Each member having livestock in the sale shall be responsible to see that the purchaser receives the livestock and, if necessary, help load the animals.

Exhibitors are limited to sell one market steer, two market swine, three market lambs, two market OR dairy goats, and three market broilers in the sale.

Market Beef must weigh 900 pounds or more to be sold in the sale.

Market Swine must weigh 220 lbs. or more.

Market Lambs and Bottle lambs must weigh 90 lbs. or more.

Market Goats and Bottle kid goats must weigh 45 lbs. or more.

Exhibitors must wear a shirt with a 4-H or FFA emblem on it while participating in the auction. Shirts must be completely intact and not defaced, long pants, closed shoes (no flip flops or sandals) and no hats will be allowed.

The Overall Grand Champion and Overall Reserve Grand Champion animals are selected to be sold at the beginning of the auction of their species.

Following the Grand Champion and Reserve Grand Champion animals the sale order will be determined by a random drawing of the 4-H/FFA exhibitors' names prior to the auction.

If a member decides NOT to sell their Overall Grand Champion or Overall Reserve Grand Champion at the auction, they cannot substitute another animal to sell in that slot. A different animal can be chosen to sell, but it will be sold in the member's randomly drawn slot

#### **GENERAL RULES**

All projects must be pre-registered in the class, in the FairEntry program by July 1, to exhibit in the show. Animals must be owned and cared for by the 4-H/FFA member no later than July 1.

#### **ALL POULTRY AND BIRDS HAVE TO BE TESTED.**

Poultry will be tested for Pullorum Disease.

State law requires that all poultry be blood tested for these diseases if they are being transported to exhibit.

All birds testing negative will be housed at the fair while those testing positive will be sent home.

**Exhibitors must be present at testing with their birds**

**Rabbits will be checked, by the Fair Vet/Rabbit Committee, and exhibitors notified if a health issue is suspected during check-in.**

*EXHIBITORS ARE RESPONSIBLE FOR KEEPING THEIR PENS AND DISPLAYS CLEAN AND TIDY.*

Rabbit exhibits should have a water and feed container provided by the exhibitor and attached to cage so that it cannot be tipped over by the animal(s).

Poultry exhibits will be provided with feed and water container by the Fair Board, except large outdoor pens.

**No paper cups or milk jugs will be allowed as water or feed containers.**

Animals must always have fresh water and fed as necessary.

**Each exhibitor must furnish their own feed and care.** Pens will be furnished.

Bedding must be changed twice a day. **The livestock neglect policy will be enforced.**

Bedding will be supplied during the fair, courtesy of the **SE Iowa Pigeon Club for the Rabbit and Poultry projects only.**

**No pet carriers are allowed under tables from Wednesday until Monday.** Carriers are allowed to transport animals from the coops to the show area, but not to stay under tables for the duration of the fair.

In accordance with rules set for the Iowa State Fair, all participants at Des Moines County 4-H horse activities will wear American Society of Testing Materials (ASTM) and Safety Engineering Institute (SEI) approved protective head gear with chin strap and properly fitted harness when **mounted and riding during all riding classes and at any time while mounted during a 4-H horse activity.**

It is the responsibility of the rider or the parent or guardian of the minor rider to see to it that the headgear complies with such approved standards and carries the proper seals and is properly fitted and in good condition. Iowa State University Extension staff, organizing committees or leaders are not responsible for checking headgear for compliance. Iowa State University makes no representation or warranty, expressed or implied, about such headgear and cautions riders that serious injury may result despite wearing headgear, as no helmet can protect against all foreseeable injuries in equestrian sports.

At any time during a Des Moines County horse riding sessions or show, the 4-H committee members and staff may check a participant's equestrian helmet for proper standards. Individuals found to be wearing an unapproved or defective helmet will not be permitted to participate in the activity until a proper helmet is acquired.

There will be a mandatory viewing of the videotape Every Time, Every Ride for new members who have not watched it. This tape explains the need for the helmet policy and how the helmet should fit.

**In compliance with Iowa State regulations, each horse may be identified and exhibited by only one 4-H member per class. Each member may identify up to five horses: of those five, two can be leased. Families with more members than horses - a horse can be identified by more than one youth but can only be exhibited once per class.**

### **GENERAL RULES**

Current health certificates are required for all equine to show at the fair, if not inspected at the last riding session. All equines should have current vaccinations.

No excessive use of whips, bats, spurs, or reins will be tolerated.

Each exhibitor must keep horse under control or be excused from the grounds.

Three head (horses and/or ponies) may be brought to the fair by any one exhibitor. Mare with foal is considered as one head. Nothing older than a weanling horse or pony stallion may be entered. All horse & pony ages will be calculated from the common date of January 1.

### **DRESS FOR SHOW:**

Exhibitors must wear a solid plain front button or snap long sleeve collared shirt (no T-shirts), dark denim jeans, and western boots. 4-H chevrons or arm bands are required in all classes. They are to be worn on the upper left arm or the upper left chest. 4-H ties are optional.

**English tack and regular 4-H attire are required for Class 31390 and English tack is optional in classes 31400, 31401, 31402 and halter. If you compete in English classes at the state level, you will be required to wear English attire per 4-H Rules and Regulations book 4H511C.**

**Cowboy hats are optional in both halter and showmanship classes.**

**ALL exhibitors are required to attend the mandatory meeting and at least 2 riding sessions or no meeting and at least 3 riding sessions, with their horse and actively participate in them, or they will not be allowed to exhibit at fair. Exhibitors are required to have on hard soled heeled boots and denim or black jeans.**

One exhibitor per animal in showmanship and equitation classes.

All ponies will be measured and 1/2" will be allowed for ponies with shoes. Any equine 14.1 and over will be considered a horse. (14.1 hands equals 57")

\*Winning 1st place in the DMC Fair Walk- Trot class will move a 4-H member to pleasure classes. Placing in the top 3 of any local show (in a class of 5 or more) prior to the DMC fair will move up a 4-H member to pleasure classes.

Members will have two (2) calls at the gate. Failure to answer will result in official scratch.

Point System for High Point Awards will be as follows:

- 1st place - 6 points
- 2nd place - 5 points
- 3rd place - 4 points
- 4th place - 3 points
- 5th place - 2 points
- Participation - 1 point

Division trophies will be awarded to the high point exhibitor in the performance class division and the speed class division, with the classes divided as follows:

Performance Class Division: 31390, 31391, 31392, 31393, 31394, 31395, and 31396

Speed Class Division: 31500, 31501, and 31502

Grand Champion Overall High Point: All Classes excluding Showmanship.

Division and Overall trophies must be one horse, one rider. Members must indicate at check in, which horse to track points on for high point awards if more than one horse is used during the show.

Trophies will be awarded at the end of the show.

Straight ribbons will be given for all classes and rosettes for 1st place and overall winners.

A trophy will be awarded in every class.

### HALTER CLASSES

All exhibitors are encouraged to show their horses and ponies at halter. Equine shown at halter are judged on conformation, general appearance, soundness, action, grooming, training, and manners. **Leased horses may not be shown at halter.**

#### **PONY HALTER (under 14.1 hands or 56")**

Class 31100 - Pony Halter - 3 yrs. old and under

Class 31101 - Pony Halter - 4 yrs. old and over

#### **HORSE HALTER (over 14.1 hands or 57")**

Class 31102 - Horse Halter - 3 yrs. old and under

Class 31103 - Horse Halter - 4 yrs. old and over

#### **GRAND AND RESERVE CHAMPION HALTER CLASS**

This class will judge 1st and 2nd place in all pony and horse halter classes for an overall halter winner and reserve winner.

Pleasure horses will be shown at a walk, jog-trot, and lope in both directions of the ring.

Horses will be asked to back.

Class 31390 - English Pleasure

Class 31391 - Western Novice Walk-Trot, Horse or Pony

**(For exhibitors with limited show experience see starred rule in the Horse General Rules)**

Class 31392 - Ranch Horse Pleasure

Class 31393 - Western Horse Pleasure

### **HORSEMANSHIP CLASSES**

The ideal horsemanship seat is one that permits the rider to sit the horse comfortably at all gaits, to have positive control without strain on the horse or rider and conveys the impression of the horse and rider being in harmony.

Junior riders will not be asked to dismount.

Class 31401 - Intermediate Horsemanship - Grades 7-9 (judge's discretion)

**Reining pattern number 1** will be used. (See below)

Western Pleasure rules apply.

The judge will indicate with markers on arena fence or wall the length of the pattern. Markers within the area of the pattern will not be used.

Ride pattern as follows:

- 1.to 2 Run with speed, past center mark.
2. Stop and back up to center of pattern.
3. Settle horse for approximately 10 seconds. Start lope. Circle should be made inside the end markers.
- 4&5. Ride two circles to the right, first circle small and slow, second circle, larger and faster.
- 6&7. Ride two circles to the left, first circle small and slow, second circle, larger and faster.
8. Left roll back over hocks, should be made past far end marker.
9. Right roll back over hocks, should be made past far end marker.
10. Stop; should be made past center marker. Let horse settle, then in approximate area of stop, do the pivots.
11. Pivot right or left no more than 90 degrees.
12. Pivot opposite direction, no more than 180 degrees.
13. Walk to judge for inspection and dismissal.

**Mandatory Exhibitor Meeting to be held 15 minutes prior to the show**

**Committee members:** Chair: Travis Holsteen, Jason McClure, Stephanie Hightower, Jordan Steffener, Craig Belknap, Jerry Malone, and Gavin Holsteen

#### **GENERAL BEEF RULES**

**All animals must be broke to lead and shown in the show ring by exhibitor. Animals not broke to lead are to be left at home. Animals with horns will not be allowed to show or sell. The Beef Committee has the right to evaluate unmanageable animals and bar them from showing. They will be sent home immediately.**

All animals must be in the barn 9:00 a.m. to 9:00 p.m. **ALL cattle to tie outs after 9:00 p.m.** No cattle allowed in the tie outs until after fireworks.

**Home Raised Market Beef, Breeding Heifer, or Cow-calf pair must be born and raised on member's family farm operation or be a Returning Bucket Bottle Calf. These are to be designated at the December weigh-in.**

All home raised beef animals are eligible to show in the Home Raised Class. There will be a market home raised class and a breeding home raised class. Each exhibitor can choose one home raised animal to show in each class. This will be entered on show day **not** in FairEntry. A sign up will be available on show day like showmanship. No ribbons or premiums will be awarded for this class; however, a champion and reserve will be awarded a trophy in both the market home raised and breeding home raised classes.

No grooming chutes, butt fans or kick boards allowed in the beef barn. **All fans must be hung in the front half of standing animal on the non-show side (left side).** All cattle must be groomed in the show arena.

**Exhibitors are NOT allowed to bring large cooling devises, except for fans, to the fair. The Fair Board reserves the right to implement cooling devices when needed.**

**No chutes allowed in the livestock area until Thursday evening. Chute space will be assigned Thursday evening.** Chutes will be allowed in the show ring after beef committee release and must be set up by 7:00 AM. There will be a \$10.00 charge per chute. **One half hour after the conclusion of the Beef Show, ALL grooming chutes MUST be out of the south end of the arena before the Dairy Show begins.**

**All tack and related items must be removed from tie outs by noon Monday.** On sale day all tack and related items must be removed from beef barn before the auction starts due to clean up. Market cattle to be sold in the livestock auction will begin weighing at 7:30 A.M. on sale day.

They will be weighed in sale order and taken directly to the arena.

**It shall be the prerogative of the beef committee to reduce the number of stalls assigned to a member to the number actually required.**

### MARKET BEEF RULES

Market animals must have been weighed in at the December 17, 2022, weigh-in.

**All registered animals must be tattooed prior to beef weigh-in in December.**

Members may weigh up to ten animals on December 17, of which any combination of the 10 may be Market Beef Steers, Market Heifers, or Market Dairy Beef

- All Dairy Beef will be evaluated for Dairy characteristics by the Beef Committee.
- Returning Bucket Bottle animals must cross the scale, weigh, and be identified at weigh in on December 17.
- An animal can be shown in only one division.

Members may exhibit four market animals providing one is a Dairy Beef or Market Heifer but may sell only one in the market livestock sale on August 1.

**All market animals entered will be weighed at the fair from 5:00 - 8:00 P.M. on Tuesday July 25.** From those weights, classes will be set up. Exhibitors must identify at this time if they are showing in the crossbred or registered class. Individual entries will be allowed to show in their breed class.

Original registration (No Copies) papers for Market animals must be presented to beef committee members at weigh-in on July 25. Tattoos will be checked. Lack of registration papers will result in the animal being shown in the crossbred division.

Crossbreds will be shown by weights in 3 divisions. All registered market animals will be shown in their respective breed classes. Breed Class Winners will show for Champion and Reserve Champion breed steer.

Grand and Reserve Grand Champion Market animals will be selected from the following division winners: Market Dairy Beef, Returning Bucket Bottle, Market Heifer, Breed Steer and (3) three Crossbred weight divisions.

Each Market Steer and Market Heifer entered will compete for Rate of Gain. The best Market Steer and the best Market Heifer of each exhibitor will be paid premium for Rate of Gain. The top ten Rate of Gain beef animals will be recognized (fitting optional). In addition, all Market Steers will be evaluated for Rate of Gain as follows: 2.5 lbs and up - blue ribbon, 2.0-2.49 lbs - red ribbon, and 1.99 lbs & lower - white ribbon. All Market Heifers will be evaluated for Rate of Gain as follows: 2.26 lbs & up - blue ribbon, 2.01-2.25 lbs - red ribbon, and 2.00 lbs & lower - white ribbon. Ribbons will be distributed when Exhibitor Numbers are picked up.

## **BREEDING BEEF RULES**

**All commercial, registered, and returning bucket bottle breeding animals must have a legible tattoo listed in 4-H Online 2.0 by May 15 to show at the county fair.**

Tattoos will be verified at weigh-in. **No fresh tattoos.**

Breeding animals that have an unreadable tattoo will be dismissed from the show.

Returning Bucket Bottle Breeding Beef **WILL NOT** be eligible for the auction as they are not a market animal.

For breeding beef heifer classes, members may exhibit one to three heifers. A member may show no more than two beef cow-calf pairs. Beef cows must be born before January 1, 2023.

The cow must be exhibited with a calf at side and the calf must be halter broke. The beef cow-calf will be tied in stalls, there will be no pens in the barn.

Breeding animals will be shown by breeds. They will not be eligible for sale.

**All Breeding animals will be weighed Tuesday, July 25, 5:00 - 8:00 P.M.**

Exhibitors must identify at this time if they are showing in the commercial or registered class. Individual entries will be allowed to show in their respective breed divisions.

Original registration (No Copies) papers for breeding beef and market animals must be presented to beef committee members at weigh-in on July 25. Tattoos will be checked. Lack of registration papers will result in the animal being shown in the commercial class.

Beef breed champions, commercial champion, and cow-calf pair will compete for Supreme Champion and Reserve Supreme Champion Female.

However, an alternate, immediate family member (sibling in 4-H/FFA) can exhibit the animal, as a yearling, if the exhibitor has not joined 4-H yet.

### **BEEF PRODUCTION CARCASS CLASS**

The Beef Production Carcass Class helps exhibitors to develop a better sense of carcass value for their market animal and ties exhibitors to all production phases, especially the consumer market. The scanning data may also serve as an educational tool in selecting breeding stock.

**\*Entry for this class will be announced at a later date. Postcard information will be sent to all Market Beef Exhibitors with date, time, and place of Beef Production Carcass weigh-in.**

#### **Eligibility Requirements:**

- A. Production Carcass entries: Market Steers or Market Heifers.
- B. Production Carcass entries must have been weighed at the beef weigh-in on December 17, 2022.
- C. Production Carcass entries must be shown as either a crossbred Market Beef, registered Market Beef, Market Dairy Beef, Market Returning Bucket Bottle Calf, or Market Heifers in the Beef Show.
- D. The Production Carcass entries must be halter broke and going to be shown at the 2023 Des Moines County Fair.

#### **Scanning Information:**

- A. This is not a terminal class.
- B. Animals will be ultrasound scanned to determine carcass measurements.
- C. Entries will be placed on a “value of lean produced per day of feed,” which considers rate of gain, rib eye area, fat cover, estimated percent internal fat, USDA quality grade, estimated carcass weight and carcass value.
- D. A \$10.00 scanning fee will be assessed per head, payable to Des Moines County Cattlemen, at the carcass scanning. The Cattlemen will pick up the remainder of the cost.

#### **Recognition and Awards:**

- A. Trophies awarded to Champion and Reserve Champion Steers and Champion Heifer.
- B. Top ten Production Carcass animals will be recognized during the Beef Show.
- C. Top ten Production Carcass animals will receive a cash award from the Des Moines County Cattlemen. (No other premiums will be awarded)

Dog Identification, **along with proof of rabies shot and current vaccinations**, are due in 4-H Online 2.0 by May 15, 2023.

Dogs will come in just for the show on Monday, July 31, starting at 7:30 a.m.

Dogs should be on the grounds by 7:45 a.m. for registration.

Each exhibitor **must attend** a mandatory meeting held June 5, 2023, at the Agri Livestock Arena on the fairgrounds. The animal must have a hard copy of current update of vaccinations, due at this mandatory meeting. **Dogs must have current rabies shot to show.**

Dog project trainings will be offered prior to the fair.

**4-H dog project Novice and Experienced exhibitors must attend 4 of the 7 dog training sessions with their dog, for safety reasons.**

**Advanced exhibitors must attend 3 of 7 dog training sessions with their dog, for safety reasons.**

Bring a six-foot leather lead strap and a correctly fitted choke collar with 3-inch excess slack when chain is tight to the first training session.

Only exhibitors may participate in practice sessions.

**Dogs are to be watered before and after training sessions.**

Aggressive/vicious behavior will not be tolerated.

In the event aggressive/vicious behavior occurs; a dog and exhibitor may be moved to a different location, or an exhibitor may be asked to muzzle the dog at any time, or an exhibitor may be asked to remove the dog from the fair grounds.

Dogs asked to be removed may participate in future practice sessions only if properly muzzled. In extreme cases, a dog may be barred from exhibiting at the fair.

If the dog is muzzled during the show, it will not be held against the dog or 4-H'er. If the dog has had to be muzzled during practice sessions, it will be muzzled during the show.

A majority vote of the committee has final ruling on the muzzling of the dog.

Absolutely no one, other than dog exhibitors and committee members, will be allowed in the show ring or holding area.

Exhibitor must be prepared to lead the dog and demonstrate training given to the dog as well as his obedience in the ring.

This is not an AKC sanctioned dog show. However, AKC rules have been used as guidelines.

A plaque will be presented to the exhibitor and dog who score the highest total points of each class.

The Dog Showmanship award can be won by a 4-H'er only once in each division.

### **OBEDIENCE**

Exhibitors are judged on how well the dog is trained.

Ribbons based on the following percentages:

BLUE 85—100 %

RED 75—84 %

WHITE under 75 %

Dogs will heel, stand for examination, recall, sit for one minute and down for three minutes, all on leash.

**Class 30100 - Novice Class** (1st year exhibitor in 4-H dog show).

**Class 30101 - Experienced Class** (2nd and 3rd year exhibitor in 4-H dog show).

**Class 30102 - Advanced Class** (4 or more years exhibitor in 4-H dog show).

### **HANDLING**

Exhibitors are judged on how well they handle their dog, not on the confirmation of the dog. Exhibitors should be prepared to do a T-pattern, L-pattern, triangle pattern, down and back, stand for exam, and answer a question at the discretion of the judge.

Handling classes will be judged using the following point system.

Exhibitor (appearance, attitude) .....15 points

Dog grooming and condition.....25 points

Handling.....30 points

Question.....30 points

Total.....100 points

Ribbons will be awarded as follows:

PURPLE: High Point

### **Mandatory Exhibitor Meeting to be held 15 minutes prior to the show**

### **GENERAL RULES**

Market goats must have been ear tagged and identified by the family no later than May 1. TEN (10) market goats can be nominated by a 4-H member.

Any 4-H member taking meat goats to the State Fair must identify those goats by May 1 and have them retinal eye scanned.

All Market and Breeding Goats must be scrapie tagged before May 1. All goats must be identified with a registered scrapie tag number except Bottle Kid goats. Birthdates will be collected for all breeding does. All Junior Breeding Does must have a county 4-H or FFA ear tag.

All goats must be banded or castrated (no clamping) by May 1. This includes bucket bottle animals, excluding Produce of Dam.

Home Raised Goat must be born and raised on member's family farm operation. These are to be designated in 4-H Online 2.0. Home Raised animals will be recognized at the Fair.

Exhibitor may show only 4 breeding goats per class.

Exhibitors can bring up to four (4) market goats. If you bring four (4) market goats, one (1) of these goats can be identified as the production market goat.

Meat goats are required to be on a chain collar or leather show halter with a chain.

Bracing is allowed. Exhibitors may lift feet off the ground when posing/setting the goat.

All goats must have four feet on the ground in the show ring during judges' evaluation.

Exhibitors lifting feet off the ground or placing them on any support or altered ring surface during judges' evaluation is not acceptable.

Exhibitors will receive one warning if they are found lifting or slapping goats during judges' evaluation. Second offenses will result in automatic exhibitor disqualification from the 4-H Meat Goat Show.

All goats planning to sell in the Auction will be weighed at 8:00 am on sale day.

Bucket Bottle Meat Goats will have their own respective show.

All market and bucket bottle, of meat goat variety, will compete together in showmanship following the bucket bottle meat goat show.

### INDIVIDUAL MARKET GOAT

#### **Class 23200 - Individual Market Goat**

Exhibitors may show a maximum of 4 market goats born on or after October 1, 2022.

Individual market goats will be weighed upon arrival at the fair.

Individual market goats must come from the goats identified by May 1.

**Market goats can show in market or breeding classes, not both.**

Division champions and reserve champions will be selected in each weight division:

#### **Class 23290 - Market Goat Pair**

Any goat not having a readable ear tag or scrapie tag will not be eligible for Rate of Gain competition.

The best goat of each exhibitor will be paid premium for Rate of Gain.

Rate of Gain will be based on 81 days from 5/6 to 7/25.

## PRODUCE OF DAM

### **Class 23201 - Produce of Dam**

### **GENERAL RULES**

Any evidence of neglect, such as open halter burns, etc., or disease such as Club Lamb Fungus, ringworm etc. will eliminate that animal from exhibition and the animal must immediately leave the fairgrounds.

Any lamb that does not pass the health inspection will be sent home.

Market lambs must have been ear tagged and identified by the family on or before May 1.

Thirty (30) market lambs can be nominated by a 4-H member and only SIX (6) can be brought to the Fair.

Any 4-H member taking lambs to the State Fair must identify those lambs and be retinal eye scanned by May 1.

Sheep must have the original 4-H tag, from the May 6 weigh-in, in the ear to be eligible to show at the Des Moines County Fair.

All sheep (market and breeding) must have a Scrapies tag that is registered by May 6, 2023  
This is the flock number and animal number.

Only exception being Bucket Bottle Lamb which must have a scrapie tag identified by May 15 in 4-H Online 2.0.

**All market lambs and commercial ewes must be slick shorn before arriving on the fairgrounds. Lambs with longer fleece must re-shear before going through the check-in line on Tuesday, July 25. The Veterinarian and committee members reserve the right to request additional shearing if they feel the lamb has been sheared inappropriately for inspection.**

No halters in show ring.

Each individual lamb will be shown in one individual class only.

Ram lambs may not show at the fair.

Short scrotum lambs can place no higher than red.

All Breeding sheep will go over the scales at Fair weigh-in July 25.

All sheep selling in the auction will weigh at 8:00 am on sale day.

There will be a black faced division and a speckled/white face division to be determined at fair weigh-in July 25 by the Sheep Committee. The speckled face division for both market and breeding lambs must have speckles on TWO of the three areas: face, ears, and/or legs. This judgment will be made at the scale.

### INDIVIDUAL MARKET LAMB

#### **Class 25200 - Individual Market Lamb (this includes Home Raised Lambs)**

Exhibitors may show a maximum of six market lambs (one of these six is the production lamb) born on or after January 1, 2023. Individual market lambs will be weighed upon arrival at fair.

Home raised and market lambs will be shown together in class 25200.

This project is open to all 4-H members. Judging will be done in three divisions:

- Class 1     4th - 6th Grades
- Class 2     7th - 9th Grades
- Class 3     10th - 12th Grades

Any newborn or orphan calf steer or heifer, dairy, beef or crossbred calved between March 1 and April 30, 2023, is eligible.

The calf must be purchased and in possession of member within 4 weeks of birth and identified in 4-H Online 2.0 by May 15.

Calves will not be ear tagged.

Calf must be bucket or bottle fed. (No nursing permitted).

An exhibitor may identify up to 2 animals but is limited to a maximum of 1 calf exhibited at the fair.

Calves will be shown at halter.

\*\*\*NOTE: New information - Completed records consisting of a general information form and feed records per calf must be turned in to the Extension Office by July 15 at 4:30 p.m. **No hard cover binders.** The judge will review the records prior to the scheduled interviews on Wednesday, July 26.

Record-keeping forms may be picked up at the Extension Office or mailed out on request.

Interviews (approx. 10 minutes) between the exhibitor and judge will be scheduled on Wednesday, July 26.

Judging will be based on:

- a. What member has learned about care and raising of the calf.
- b. General health, condition, and management of the calf and 4-H'er's knowledge of this area.
- c. A completed record sheet per calf.
- d. The fitting and showing of the calf (according to beef or dairy guidelines) with emphasis on what member has learned.
- e. Conformation or quality of the calf will not be considered since purchase should not be made on this basis.

Judging will be based on 80% records and 20% showing.

All 4-H and FFA pigs must be identified by ear notch, ear tag, sex, and color by the individual member/family in 4-H Online 2.0 by May 15. Paperwork must be turned into the Extension Office by May 15.

Each exhibitor is limited to identifying a maximum of 12 pigs.

Production Market Barrows, Production Market Gilts, and Single Source pigs are to be weighed by the individual member/family between April 1-8. Ear notch, ear tag, sex, and color need to be identified in 4-H Online 2.0, by the family, and paperwork turned in by May 15. Any barrow or gilt weighing over 65 lbs. will not be eligible for the Production Class.

Any combination of gilts and barrows may be identified in 4-H Online 2.0 and paperwork turned into the Extension Office by May 15. **It is not mandatory to have a Production Market Barrow, Production Market Gilt, or Single Source pig entry to show.**

You may identify 8 divisions in FairEntry due July 1 and exhibit four pigs in either the Individual Market Gilt class, Individual Market Barrow class, Production Market Barrow class, Production Market Gilt class, Single Source class, Purebred Market Hog class, Commercial Gilt class, or Purebred Breeding Gilt class.

**An exhibitor can show any combination of 26200, 26210, 26220, 26230, 26235, 26240, 26130, or 26135 totaling up to four pigs. Each pig can only be shown in one division.**

Exhibitors may sell 2 pigs in the auction. **The extra pigs may be removed Friday afternoon, July 28, beginning at 4:00 p.m.** You can still have two pigs for the Auction.

Any pig weighing under 220 lb. is not eligible for a blue ribbon.

**All hogs MUST arrive clean, (No caked-on dirt), and this includes legible ear tags.**

All males must have been castrated and fed as barrows.

Placing will be made according to the present-day market demands of a meat type pig that yields a high percentage of the most desirable cuts of meat, dressing percentage, finish, average daily gain, and desirability of market weight.

Any member may sell a maximum of two pigs in the market auction sale.

Blue, red & white ribbons and premiums will be given for Rate of Gain as follows: 1.86 lbs & up - blue, 1.30 - 1.85 lbs - red, 1.29 lbs & below – white

Home Raised Barrow or Gilt must be raised on member's family farm operation. These are to be designated at the July weigh-in. Home Raised animals will be recognized at the 2023 Fair.

**Each Home Raised exhibitor is allowed to bring one home raised pig back into the arena for the selection of Champion and Reserve Champion Home Raised pig.**

**All swine are suggested to be farrowed after January 1, 2023.**

**All Swine leaving the Fair Grounds must fill out appropriate paperwork.**

Division Champions and Reserve Champions will be selected in each weight division: Light Weight, Medium Weight and Heavy Weight. Division Champions and Reserve Champions will receive rosettes. Grand and Reserve Champion Individuals selected from these classes will receive a ribbon and banner.

**\*\*\*An exhibitor can show any combination of 26200, 26210, 26220, 26230, 26235, 26240, 26130, or 26135 totaling up to four pigs. Each pig can only be shown in one division.**

### **INDIVIDUAL MARKET BARROW(S)**

**Class 26200** - Individual Market Barrow

This class is designed to give an over-all view of total hog production.

The entries in this class must be a barrow.

The individual market barrow(s) must have been identified by May 15, 2023.

### **INDIVIDUAL MARKET GILT(S)**

**Class 26210** - Individual Market Gilt

This class is designed to give an over-all view of total hog production.

The entries in this class must be a gilt.

The individual market gilt(s) must have been identified by May 15, 2023.

### **PRODUCTION MARKET BARROW(S)**

**Class 26220** - Production Market Barrow - (automatically goes into Carcass Class)

Each member may show maximum of 4, which will also be the carcass entries.

Each barrow entered in the production class will compete in Rate of Gain.

These pig(s) must have been weighed between April 1-8, by the member and their family, and weigh 65 lbs. or less. This Production Market Barrow must be the carcass barrow and is automatically entered in that class.

### **PRODUCTION MARKET GILT(S)**

**Class 26230** - Production Market Gilt - (automatically goes into Carcass Class)

Entries in this class must be a gilt.

Each member may show maximum of 4, which will also be the carcass entries.

Each gilt entered in the production class will compete in Rate of Gain.

These pig(s) must have been weighed between April 1-8, by the member and their family, and weigh 65 lbs. or less. This Production Market Gilt must be the carcass gilt and is automatically entered in that class.

The Swine Committee has the right to combine Class 26220 and Class 26230 if lack of numbers dictates.

### **SINGLE SOURCE HOG(S)**

**Class 26235** – Single Source Hog(s)

To compete in this class, the pig(s) must be purchased from Tri Oak and have gone through the April weigh-in.

Single Source Hogs must be identified by May 15, 2023.

Participants can purchase up to 5 pigs from Tri Oak but show a maximum of 1 in the Single Source class. All other Tri Oak purchased pigs are eligible to show in the remaining swine classes.

Pigs will be selected and distributed on a first come, first serve basis as they are weighed at pick up.

Classes will be split by participant grade:

Junior: 4-6 grade

Intermediate: 7-9 grade

Senior: 10-12 grade

The Swine Committee has the right to combine grade levels if a lack of numbers dictate.

Single Source pigs will be scanned at the Fair weigh-in. These pigs are eligible for overall carcass and Rate of Gain awards.

A project interview is required to participate in this class and is scheduled for Wednesday, July 26, beginning at 9:00 a.m. Exhibitors will be sent an interview schedule prior to Fair.

The final class awards will use a variety of input totaling 100 points: Scan data = 45 pts.;

Interview = 45 pts.; and Show Ring presence = 10 pts.

### **PUREBRED MARKET HOG(S)**

**Class 26240** - Purebred Market Hog(s)

Entries in this class may be a barrow or a gilt.

Purebred market hogs must be identified by May 15, 2023.

Original registration papers (no copies) must be presented to the swine committee at weigh-in on July 25.

Lack of registration papers will result in the animal being shown in the Individual Market class.
